All Your use of AXIS Audio Manager Pro will be governed by Axis General License Agreement (available at <u>License agreements | Axis Communications</u>) and these Product Specific Terms for AXIS Audio Manager Pro (these "**Terms**"). These Terms shall prevail in case of any conflict with the Axis General License Agreement. Any capitalized terms defined in the Axis General License Agreement that are used in these Terms shall have the meaning ascribed to them in the Axis General License Agreement.

IMPORTANT: By downloading, installing, activating, accessing or otherwise using AXIS Audio Manager Pro, You accept and agree to be bound by the terms and conditions of the Agreement. If You are accepting the Agreement on behalf of a company or other business entity, that entity will be deemed the Customer hereunder and You represent and warrant that You have authority to legally bind that entity to the Agreement. If You do not have such authority or You do not agree to the terms of the Agreement, neither You nor the entity is permitted to and may not download, install, access or use AXIS Audio Manager Pro.

1 ABOUT AXIS AUDIO MANAGER PRO

AXIS Audio Manager Pro is an audio management system. It provides centralized control and configuration of audio content, scheduling, and live announcements across multiple zones in a large facility. The software supports advanced features such as user and role management, priority between content, integration with third-party systems, and system health monitoring.

2 LICENSE

- 2.1 The applicable license type is either Axis Subscription Model or License Tied to Hardware as follows:
- 2.1.1 For AXIS Audio Manager Pro distributed standalone, without being preloaded or otherwise tied to an Axis Product, the Axis Subscription Model as set out in the Axis General License Agreement applies.
- 2.1.2 For (a) AXIS Audio Manager Pro that comes preloaded in an Axis Product or (b) licenses for AXIS Audio Manager Pro that are purchased separately but are tied to an Axis Product, the Software License Tied to Hardware as set out in the Axis General License Agreement applies. Notwithstanding anything to the contrary in the Axis General License agreement, the Use Term for this license type is the lifetime of the server hardware for the Axis Product to which the license is tied. If a major component of the server hardware is replaced or becomes nonfunctional, or if the Axis Product's ID is otherwise compromised, the Usage Rights will expire. However, the Usage Rights will not expire if the replacement of a major component is performed as part of the onsite-support service during the warranty period of the Axis Product. In the case of RMA, the

Usage Rights tied to the faulty Axis Product will no longer be effective, and the Usage Rights tied to the replacement Axis Product will apply instead.

2.1.3 AXIS Audio Manager Pro includes a public API, documented here: https://developer.axis.com/vapix/audio-systems/axis-audio-manager-pro-api/. The API allows customers to programmatically interact with an existing AXIS Audio Manager Pro installation. The API is disabled by default and needs to be actively enabled by You if You wish to use it. For the avoidance of doubt, nothing in the Axis General License Agreement shall be construed as preventing or prohibiting the use of this API with AXIS Audio Manager Pro.
