

PRODUCT SPECIFIC TERMS

FOR

AXIS IP Utility

All Your use of Axis IP Utility will be governed by Axis General License Agreement (available at <https://www.axis.com/legal/license-agreements>), including any other documents or terms referenced therein (together the “**GLA**”), as supplemented by these Product Specific Terms for Axis IP Utility (these “**Terms**”). The GLA and these terms together form the “**Agreement**”. These Terms shall prevail in case of any conflict with the GLA, unless specifically stated otherwise in such conflicting terms. Any terms defined in the GLA and used in these Terms shall have the meaning ascribed to them in the GLA, unless otherwise stated herein.

IMPORTANT: By downloading, installing, activating, accessing or otherwise using Axis IP Utility, You accept and agree to be bound by the terms and conditions of the Agreement. If You are accepting the Agreement on behalf of a company or other business entity, that entity will be deemed the Customer hereunder and You represent and warrant that You have authority to legally bind that entity to the Agreement. If You do not have such authority or You do not agree to the terms of the Agreement, neither You nor the entity is permitted to and may not download, install, access or use Axis IP Utility.

1. ABOUT AXIS IP UTILITY

AXIS IP Utility is a tool to facilitate Your installation and configuration of Axis products. AXIS IP Utility may also be used with compatible third-party devices at your own risk. More information about IP Utility can be found in its Documentation.

2. LICENSE AND USE TERM

2.1 License grant:

The following replaces the grant of license in Section 3.1 in the GLA solely as it pertains to AXIS IP Utility:

Subject to the terms and conditions set out in these Terms and the Axis General License Agreement, and Your compliance therewith, Axis grants You a world-wide, non-exclusive, non-transferable, non-sublicensable, revocable, limited right during the Use Term to download, install and use the AXIS IP Utility with Axis Products for Your internal business purposes, in accordance with the Agreement, including the Documentation, any user manual, usage instructions, and/or product documentation concerning Axis IP Utility published by Axis from time to time.

License Type: One-Time License.

Use Term: Perpetual, subject to termination rights under the Agreement and at law.

Number of licensed Axis Products: Unlimited.

2.2 Compatibility with Third Party Services:

AXIS IP Utility is created specifically and solely for use as an aid for installing and configuring Axis products. However, as mentioned in the GLA it may also be possible to install and configure certain compatible third-party products with the AXIS IP Utility. This license also permits You to do so, at your own risk, and You expressly acknowledge and agree that section 7 of the Axis General License Agreement (Third Party Services) applies to any such use and that Axis has no obligation to implement or maintain any compatibility with Third Party Services.

3. THIRD PARTY SOFTWARE/NOTICES

Axis IP Utility includes Third-Party Software and Open Source Software. The applicable Third-Party License Terms and Open Source License Terms are available when installing, and from within, the AXIS IP Utility.
