## 1. 8.33 fps Version

### Classification Information:

Products operating at a frame rate  $\leq 9$ fps are not controlled for export under European Commission Customs legislations. They may be exported under NLR (No License Required) to all countries except embargoed.

### Permanent / Temporary Exports:

These cameras may be shipped NLR to all countries except embargoed.

### Statement:
