

AXIS CAMERA STATION SOFTWARE LICENSE AGREEMENT

This Software License Agreement (this "Agreement") is a legal agreement between you (either individual or an entity) and Axis Communications AB (hereinafter referred to as "Axis") for the licensing of the **Axis Camera Station Software**, developed and owned by Axis (the "SOFTWARE").

BY CLICKING ON THE "I ACCEPT" BUTTON, OR BY DOWNLOADING, INSTALLING, ACTIVATING OR COPYING OR OTHERWISE USING THE SOFTWARE, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS AGREEMENT. PLEASE ENSURE THAT YOU HAVE CAREFULLY READ AND PROPERLY UNDERSTOOD THE ENTIRE AGREEMENT BEFORE AGREEING TO ITS TERMS AND CONDITIONS. IF YOU DO NOT AGREE TO ALL OF THE TERMS OF THIS AGREEMENT, CLICK THE "I DON'T ACCEPT" BUTTON AND THE INSTALLATION PROCESS WILL BE SUSPENDED.

1. THE SOFTWARE

The SOFTWARE is a video management software, intended for use in a client-server model system, i.e. a system of connected service providers (servers) and service requesters (clients). For the purpose of this Agreement, a "Client" shall mean a service requester capable of visual display, such as a laptop, PC or smartphone, connected to your security system.

2. GRANT OF LICENSE.

The SOFTWARE is created specifically and solely for use with Axis network video products or other Axis devices ("Axis Products"), or third party compliant network video products or other devices ("Third Party Compliant Products") supported by the SOFTWARE as indicated by the Axis Camera Station Compatibility Test Tool, available for download at www.axis.com. Subject to the terms and conditions of this Agreement and all applicable laws and regulations, Axis grants to you a non-exclusive right to install the SOFTWARE and use the SOFTWARE with Axis Products or Third Party Compliant Products only. The SOFTWARE is in "use" on a computer when it is loaded into temporary memory (i.e. RAM) or installed into permanent memory (e.g. hard disk, CD-ROM or other storage device) of that computer.

Use of AXIS Video Content Stream, enabled by AXIS Video Content Stream application which is installed through the SOFTWARE, is only permitted through the SOFTWARE.

Information relating to the number of SOFTWARE licenses needed for your security system is available at www.axis.com and provided to you prior to your purchase. The license granted herein entitles you to install and use such number of copies of the SOFTWARE as corresponding to your purchase. If and when you extend your security system in a way that requires additional SOFTWARE licenses, you are welcome to acquire such licenses from Axis.

3. IMPORTANT NOTICE: DECODER LICENSES

The SOFTWARE supports MPEG-4, H.264, H.265 and/or AAC by use of a decoder provided in each Axis Product producing video (i.e. a network video camera or a network video encoder, "Axis Video Producing Product"). Axis has procured the relevant license to such decoder, and said license is included in the purchase of an Axis Video Producing Product. Please note however:

- a) **If you have more Clients connected to your security system than you have Axis Video Producing Products, you will need to acquire additional decoder licenses from Axis.**
- b) **If you use the SOFTWARE together with a Third Party Compliant Product, you are responsible for procuring the relevant decoder licenses yourself (if they are not already included in the Third Party Compliant Product) and for ensuring that your use of the SOFTWARE will be in accordance with the terms and conditions of such licenses.**

4. COPYRIGHT.

The SOFTWARE contains copyright protected material, trade secrets and other proprietary information and material of Axis and/or its licensor(s), if any, and is protected by copyright laws, international copyright treaties and trade secret laws, as well as other intellectual property laws and treaties. The SOFTWARE is licensed, not sold to you, and it can only be used in accordance with the terms of this Agreement. Except as expressly authorized in this Agreement or by applicable law, you may not:

- b) reverse engineer, decompile, disassemble or create derivative work of the SOFTWARE;
- c) make more copies of the SOFTWARE than as specified in this Agreement;

- f) use the SOFTWARE for commercial software hosting services; or

The SOFTWARE may collect and process certain technical data relating to the installation and use of the security system of Axis Products or Third Party Compliant Products (as applicable). Such data will be used by Axis for the purpose of facilitating the provision of updates and upgrades of the SOFTWARE, support and other services to you with regard to the SOFTWARE. Personal data (i.e. data that can be used to identify an individual) will not be collected and processed unless you have consented thereto in connection with your on-line registration for MyAxis account.

Further to the above, the SOFTWARE will regularly connect to Axis systems in order to recognise and provide to you information regarding available updates or upgrades of the SOFTWARE, product news and other similar information relating to the use of the SOFTWARE.

8. TERMINATION.

This Agreement is effective until terminated. Your rights under this Agreement will terminate automatically without notice from Axis if you fail to comply with any term(s) of this Agreement. Upon the termination of this Agreement, you shall cease all use of the SOFTWARE and destroy all copies, full or partial, of the SOFTWARE.

This agreement shall be deemed performed in and shall be construed by the laws of Sweden.

Preamble

The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public

Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Preamble The licenses for most software are designed to take away your freedom to share and change it. By contrast, the GNU General Public Licenses are intended to guarantee your freedom to share and change free software--to make sure the software is free for all its users.

This license, the Lesser General Public License, applies to some specially designated software packages--typically libraries--of the Free Software Foundation and other authors who decide to use it. You can use it too, but we suggest you first think carefully about whether this license or the ordinary General Public License is the better strategy to use in any particular case, based on the explanations below.

When we speak of free software, we are referring to freedom of use, not price. Our General Public Licenses are designed to make sure that you have the freedom to distribute copies of free software (and charge for this service if you wish); that you receive source code or can get it if you want it; that you can change the software and use pieces of it in new free programs; and that you are informed that you can do these things.

To protect your rights, we need to make restrictions that forbid distributors to deny you these rights or to ask you to surrender these rights. These restrictions translate to certain responsibilities for you if you distribute copies of the library or if you modify it.

For example, if you distribute copies of the library, whether gratis or for a fee, you must give the recipients all the rights that we gave you. You must make sure that they, too, receive or can get the source code. If you link other code with the library, you must provide complete object files to the recipients, so that they can relink them with the library after making changes to the library and recompiling it. And you must show them these terms so they know their rights.

To protect each distributor, we want to make it very clear that there is no warranty for the free library. Also, if the library is modified by someone else and passed on, the recipients should know that what they have is not the original version, so that the original author's reputation will not be affected by problems that might be introduced by others.

Finally, software patents pose a constant threat to the existence of any free program. We wish to make sure that a company cannot effectively restrict the users of a free program by obtaining a restrictive license from a patent holder. Therefore, we insist that any patent license obtained for a version of the library must be consistent with the full freedom of use specified in this license.

A "library" means a collection of software functions and/or data prepared so as to be conveniently linked with application programs (which use some of those functions and data) to form executables.

A "work based on the Library" means either the Library or any derivative work under copyright law: that is to say, a work containing the Library or a portion of it, either verbatim or with modifications and/or translated straightforwardly into another language. If, as a consequence of a court judgment or allegation of patent infringement or for any other reason (not limited to patent issues), conditions are imposed on you (whether by court order, agreement or otherwise) that contradict the conditions of this License, they do not excuse you from the conditions of this License. If you cannot distribute so as to satisfy simultaneously your obligations under this License and any other pertinent obligations, then as a consequence you may not distribute the Library at all. This section is intended to make thoroughly clear what is believed to be a consequence of the rest of this License.

If the distribution and/or use of the Library is restricted in certain countries either by patents or by copyrighted interfaces, the original copyright holder who places the Library under this License may add an explicit geographical distribution limitation excluding those countries, so that distribution is permitted only in or among countries not thus excluded. In such case, this License incorporates the limitation as if written in the body of this License.

13. The Free Software Foundation may publish revised and/or new versions of the Lesser General Public License from time to time. Such new versions will be similar in spirit to the present version, but may differ in detail to address new problems or concerns.

Each version is given a distinguishing version number. If the Library specifies a version number of this License which applies to it and "any later version", you have the option of following the terms and conditions either of that version or of any later version published by the Free Software Foundation. If the Library does not specify a license version number, you may choose any version ever published by the Free Software Foundation.

Our decision will be guided by the two goals of preserving the free status of all derivatives of our free software and of promoting the sharing and reuse of software generally.

EXCEPT WHEN OTHERWISE STATED IN WRITING THE COPYRIGHT HOLDERS AND/OR OTHER PARTIES PROVIDE THE LIBRARY "AS IS" WITHOUT WARRANTY OF ANY KIND, EITHER EXPRESSED OR IMPLIED, INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. THE ENTIRE RISK AS TO THE QUALITY AND PERFORMANCE OF THE LIBRARY IS WITH YOU. SHOULD THE LIBRARY PROVE DEFECTIVE, YOU ASSUME THE COST OF ALL NECESSARY SERVICING, REPAIR OR CORRECTION.

16. IN NO EVENT UNLESS REQUIRED BY APPLICABLE LAW OR AGREED TO IN WRITING WILL ANY COPYRIGHT HOLDER, OR ANY OTHER PARTY WHO MAY MODIFY AND/OR REDISTRIBUTE THE LIBRARY AS PERMITTED ABOVE, BE LIABLE TO YOU FOR DAMAGES, INCLUDING ANY GENERAL, SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES ARISING OUT OF THE USE OR INABILITY TO USE THE LIBRARY (INCLUDING BUT NOT LIMITED TO LOSS OF DATA OR DATA BEING RENDERED INACCURATE OR LOSSES SUSTAINED BY YOU OR THIRD PARTIES OR A FAILURE OF THE LIBRARY TO OPERATE WITH ANY OTHER SOFTWARE), EVEN IF SUCH HOLDER OR OTHER PARTY HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES.
